AMENDMENT TO AMENDED DECLARATION  
OF COVENANTS AND RESTRICTIONS

THIS AMENDMENT to the Amended Declaration of Covenants and Restrictions, made and entered into on this 2 day of FEBRUARY 1998, by BRIGHT WATER PLACE HOMEOWNERS ASSOCIATION, INC., a Florida corporation, (hereinafter "Association"), MORRITT-DORA, INC., a Florida corporation, (hereinafter "Developer"), and the members and owners set forth in the attached consent and approval.

WITNESSETH

WHEREAS, Bright Water Place is a subdivision in Lake County, Florida, subject to certain Amended Declaration of Covenants and Restrictions dated October 31, 1991, as recorded in Official Records Book 1250, page 2387, Public Records of Lake County, Florida; and

WHEREAS, the Association is a Florida corporation not-for-profit organized for the purposes set forth in the Amended Declaration of Covenants and Restrictions; and

WHEREAS, the attached consent and approval is executed by owners of lots in Bright Water Place, as defined in the Amended Declaration of Covenants and Restrictions; and

WHEREAS, the Developer owns certain real property which is part of the recorded plat of Bright Water Place as recorded in the Public Records of Lake County, Florida, Plat Book 31, pages 41 and 42, and the Developer retained in the Amended Declaration of Covenants and Restrictions, the right to add additional land to the property, such that the total number of lots in Bright Water Place would be not more than 124 (MOL) lots; and

WHEREAS, there are presently 59 lots in Phase I of Bright Water Place, but the Developer desires to add an additional 83 lots in second, third and fourth phases, such that the

total number of lots in the property will be 142 lots; and

WHEREAS, the parties desire that the Amended Declaration of Covenants and Restrictions shall apply to all of the lots, in Phase I and Phases II, III and IV in the platted subdivision of Bright Water Place, as amended herein; and

WHEREAS, the parties desire to amend various provisions of the Amended Declaration of Covenants and Restrictions upon the terms and conditions set forth herein, and this Amendment will supersede any provisions of the Amended Declaration of Covenants and Restrictions which are inconsistent herewith.

NOW THEREFORE, in consideration of the mutual covenants and undertakings, the parties hereto hereby agree and declare the following amendments to the Amended Declaration of Covenants and Restrictions of Bright Water Place:

1. Article II, Section 2., Additions in Accordance with a General Plan of Development, is hereby modified so that the Developer may add second, third and fourth phases to the development such that the total number of lots in Bright Water Place would be not more than 142 lots in total. The Developer shall add no further property to the development without approval of the homeowners association and approved in accordance with the requirements of the Amended Declaration of Covenants and Restrictions, as amended.

2. Article III, Section 2., Voting Rights, is hereby amended so that there are no longer two classes of voting membership and all membership shall be the same as Class A membership as defined in the Amended Declaration of Covenants and Restrictions. Class B membership is hereby eliminated.

3. Notwithstanding the provisions of Article III, Section 1., Membership, and Section

2., Voting Rights, the Developer shall not be entitled to membership in the Association, or any voting rights for any of the lots owned by the Developer in the second, third or fourth phases, which is the additional 83 lots that the Developer is adding to the development. However, upon the Developer transferring title of any lot to a third party, that third party shall be entitled to membership and voting rights in the Association as otherwise set forth in the Amended Declaration of Covenants and Restrictions, and the Articles of Incorporation and Bylaws of the Bright Water Place Homeowners Association, Inc. Notwithstanding anything in this Amendment, the Developer shall retain its right to serve on the Architectural Review Committee as presently specified in the existing Amended Declaration of Covenants and Restrictions.

4. Article IV, PROPERTY RIGHTS IN THE COMMON PROPERTIES, is hereby amended by the addition of the following section:

Section 5. Common Areas of Second, Third and Fourth Phases. The Developer shall install sprinkler systems in all landscaped common areas of the second, third and fourth phases of the development, and the Developer shall be responsible for all of the expenses for the common area maintenance and up-keep of those phases until such time as the majority of the lots in those phases (42 lots) have been transferred to third parties, at which time the Association will assume responsibility for the common area maintenance and expenses for the second, third and fourth phase common areas.

5. Article V, COVENANT FOR MAINTENANCE ASSESSMENTS, is hereby amended so that the Developer shall not be responsible for original assessments (Section 3.(a) of Article V), or annual assessments (Section 3.(b) of Article V), for the lots in the second, third or fourth phases of the development during such time as Developer owns title to those lots.

However, upon transfer of title of those lots to any third party, the third party shall be responsible for an original assessment and annual assessments. The Developer agrees that the original assessments and prorated first year annual assessments will be collected by the Developer upon the closing of the sale of any lots to third parties in the second, third and fourth phases and they shall be transmitted and delivered to the Association within five (5) days of the date of closing of such lots. The Developer shall not pay annual assessments on any lots owned by the Developer in the second, third and fourth phases until January 1, 2002, and thereafter.

Article V, Section 3., Original, Annual, Service and Maximum Assessments, subsection (b) is hereby amended so that the annual assessment of \$250.00 per house or vacant lot is payable annually on January 1 of each year.

6. Article IX, AMENDMENT BY DEVELOPER, is hereby amended so that the Association, rather than the Developer, has the amendment rights therein stated.

7. Article X, ADDITIONAL COVENANTS AND RESTRICTIONS, is hereby amended so that the Association, rather than the Developer, may approve the additional covenants and restrictions as stated therein.

8. For purposes of these amendments to the Amended Declaration of Covenants and Restrictions, should the Developer transfer title of a lot in the second, third or fourth phase to a related party, that lot shall be treated as being owned by the Developer. A related party shall mean any officer, director, or shareholder of Developer or any member of the immediate family of any such person.

9. Sufficient notice was given in accordance with Article XI, AMENDMENT, for the amendments set forth above, and this recitation shall be conclusive as to all parties who shall

have the right to rely upon this recitation set forth herein.
